## **New Business:**

## **RESOLUTION 1: BUDGET AMENDMENTS**

On motion by Supervisor Miller and seconded by Councilperson Merrill and carried, the Town Board approves the adoption of the 2026 Preliminary budget.

**WHEREAS adjustments were made to the 2026 Alexander Town Preliminary Budget after the public hearing on November 10, 2025 and those adjustments became part of the 2026 Town of Alexander Adopted Budget which was sent to Genesee County to be used for the tax warrant and**

WHEREAS the public hearing on November 10, 2025 was declared invalid because the notice of the public hearing was not published until November 11, 2025 and

WHEREAS another public hearing was held on December 29, 2025 for the preliminary Town of Alexander with all changes made before November 10, 2025 and the Preliminary Town of Alexander Budget was adopted on December 29, 2025 and

**WHEREAS it is the intent of the Alexander Town Board that the 2026 Adopted Budget reflect the tax warrant issued for Town taxes for 2026.**

**THEREFORE BE IT RESOLVED THAT the Town of Alexander 2026 Adopted Budget be amended as follows:**

Decrease HW7 8340.2 from \$5,663,000 to \$5,603,000

**Increase A 1620.4 from \$23,000 to \$25,000**

**Increase A 3902 from \$47,700 to \$ 58,500**

### Increase A 5132.4 from \$30,000 to \$70,000

Increase A 6772.4 from \$500 to \$1,500

**Increase A 8020.4 from \$53,000 to \$ 65,000**

### Increase DB 9060.8 from \$ 46,000 to \$54,000

### Increase HW7 9730.6 from \$0 to \$2,000,000

### Increase HW7 9730.7 from \$0 to \$60,000

**Increase HW7 5730 from \$0 to \$2,000,000**
